## Confidentiality Deed dated

**Parties**                    **Mr Stephen Parbery and Mr Daniel Bryant in their capacity (acting jointly) as court appointed receivers and managers to ABC2 Group Pty Ltd ABN 74 122 710 141 (Discloser)**

**The Party identified in Schedule 1 (Recipient)**

## Background

- A.            The Discloser may provide the Recipient with certain Confidential Information in relation to the Purpose.
- B.            In consideration of the Discloser disclosing Confidential Information to the Recipient or its Representatives the Recipient has agreed to keep the Confidential Information confidential and use the Confidential Information only in accordance with the terms of this deed.

## Operative provisions

---

### 1.        **Definitions and interpretation**

#### 1.1      **Definitions**

In this deed:

**ABC2 Group Centres** means the childcare centres listed in Schedule 2 or as otherwise notified by the Discloser to the Recipient from time to time.

**Confidential Information** means:

- (a)           all information relating to the Discloser, any Related Body Corporate of the Discloser, the ABC2 Group Centres or the Purpose made available at any time in any form by the Discloser or its Representatives to the Recipient or its Representatives;
- (b)           all information in any form made or derived in whole or in part by the Recipient or its Representatives from any information of the type referred to in paragraph (a); and
- (c)           the fact that the parties and their respective Representatives are or have been participating in discussions in relation to the Purpose, the substance of any such discussions, and the fact of and reasons for the termination of such discussions.

**Corporations Act** means the Corporations Act 2001 (Cth).

**Possible Transaction** means any transaction agreed to by the Discloser and Recipient pursuant to which the Recipient or its nominee acquires an interest in any one or combination of the ABC2 Group Centres.

**Purpose** means:

- (a)           conducting an assessment of whether and on what terms the Recipient will pursue or support or will continue to pursue or support a Possible Transaction;
- (b)           negotiating with the Discloser the terms of a Possible Transaction and any agreements or other documents to effect a Possible Transaction; and

- (c) the implementation of any Possible Transaction.

**Regulatory Authority** means:

- (a) any government or local authority and any department, minister or agency of any government; and
- (b) any other authority, agency, commission or similar entity having powers or jurisdiction under any law or regulation or the listing rules of any recognised stock exchange.

**Related Body Corporate** of a corporation means a related body corporate of that corporation within the meaning of section 50 of the Corporations Act.

**Representative** of a party means any Related Body Corporate of that party and any director, officer, employee or professional adviser of that party or of a Related Body Corporate of that party.

## 1.2 Interpretation

In this deed headings are for convenience only and do not affect interpretation and, unless the contrary intention appears:

- (a) a word importing the singular includes the plural and vice versa, and a word of any gender includes the corresponding words of any other gender;
- (b) the word **including** or any other form of that word is not a word of limitation;
- (c) if a word or phrase is given a defined meaning, any other part of speech or grammatical form of that word or phrase has a corresponding meaning;
- (d) a reference to a **person** includes an individual, the estate of an individual, a corporation, an authority, an association or parties in a joint venture, a partnership and a trust;
- (e) a reference to a party includes that party's executors, administrators, successors and permitted assigns, including persons taking by way of novation and, in the case of a trustee, includes any substituted or additional trustee;
- (f) a reference to an agreement (including this deed) is to that agreement as varied, novated, ratified or replaced from time to time;
- (g) a reference to a party, clause, schedule, exhibit, attachment or annexure is a reference to a party, clause, schedule, exhibit, attachment or annexure to or of this deed, and a reference to this deed includes all schedules, exhibits, attachments and annexures to it;
- (h) a reference to a statute includes any regulations or other instruments made under it (**delegated legislation**) and a reference to a statute or delegated legislation or a provision of either includes consolidations, amendments, re-enactments and replacements;
- (i) a reference to **\$** or **dollar** is to Australian currency; and
- (j) this deed must not be construed adversely to a party just because that party prepared it or caused it to be prepared.

---

## **2. Provision of Confidential Information**

- (a) Subject to this deed, the Discloser may make Confidential Information available to the Recipient from time to time for the Purpose.
- (b) Nothing in this deed requires the Discloser to make any Confidential Information available to the Recipient. The disclosure of any Confidential Information by the Discloser to the Recipient is at the absolute discretion of the Discloser.

### **2.2 Further Information**

Except where the Discloser is under a strict obligation imposed by law, the Recipient acknowledges that the Discloser is not under any obligation to:

- (a) correct or clarify any inaccurate or incomplete Confidential Information; or
- (b) update any information disclosed to the Recipient.

---

## **3. Confidentiality**

### **3.1 Confidential nature of information**

The Recipient acknowledges and agrees that the Confidential Information is confidential and of significant commercial value to the Discloser and that any unauthorised disclosure of the Confidential Information would cause loss or damage to the Discloser and its Related Bodies Corporate.

### **3.2 Recipient's obligations**

Except as expressly permitted by this deed, the Recipient:

- (a) must hold the Confidential Information in strict confidence and not disclose it or otherwise make it available to any person;
- (b) must not use any Confidential Information for any purpose other than the Purpose and, in particular, must not use any Confidential Information for its own commercial purposes or to the current or potential competitive disadvantage of the Discloser or any Related Body Corporate of the Discloser;
- (c) must not copy, extract, record or reproduce any Confidential Information except to the extent necessary to carry out the Purpose;
- (d) must store all Confidential Information so that it is protected from unauthorised access, use, copying, reproduction or disclosure and in such a way that it can be retrieved later;
- (e) must promptly notify the Discloser if it becomes aware or suspects that any Confidential Information has been, or is likely to be, held, disclosed, used, copied, reproduced or stored in a way that is inconsistent with the terms of this deed; and
- (f) promptly do anything reasonably required by the Discloser to prevent or restrain a breach or suspected breach of this deed or any infringement or suspected infringement of the Discloser's rights arising out of this deed by any person, whether by court proceedings or otherwise.

### **3.3 Disclosure to Representatives**

- (a) The Recipient may disclose or otherwise make available any Confidential Information to a Representative of the Recipient if:
  - (i) that Representative reasonably requires to access to that Confidential Information for the Purpose; and
  - (ii) the Recipient has informed that Representative that the Confidential Information is confidential and that the Representative is required to comply with the terms of this deed as if it were the Recipient,

and the Recipient must ensure that each of its Representatives to whom Confidential Information is disclosed or made available under this clause 3.3 strictly observes all of the Recipient's obligations under this clause 3 as if the obligations were imposed on that person.

- (b) The Recipient will, upon request by the Discloser, promptly arrange for any of its Representatives to execute a confidentiality deed in favour of the Discloser on terms similar to the terms of this deed.

### **3.4 Exceptions**

Nothing in this deed prevents the Recipient or its Representatives:

- (a) from using and disclosing Confidential Information to the extent that the Confidential Information is in or comes into the public domain, otherwise as a result of breach of this deed or any other obligation of confidence; or
- (b) from disclosing Confidential Information if disclosure of that Confidential Information is required to be made by law or the rules of any recognised stock exchange and:
  - (i) the Recipient or the relevant Representative notifies the Discloser as soon as reasonably practicable after it becomes aware that disclosure is required;
  - (ii) the Recipient or the relevant Representative takes all steps reasonably required by the Discloser to prevent or restrict the disclosure of the Confidential Information; and
  - (iii) unless immediate disclosure is required, the Recipient or the relevant Representative gives the Discloser a reasonable opportunity to comment on the requirement for, and proposed form of, the disclosure.

---

## **4. Return or destruction of Confidential Information**

### **4.1 Return or destruction**

Promptly following a written demand from the Discloser, the Recipient must at its own expense:

- (a) return to the Discloser or destroy or procure the destruction of all documents and other materials containing Confidential Information in the possession, power or control of the Recipient or its Representatives (whether or not created by the Recipient or its Representatives);

- (b) delete, or procure the deletion of, any Confidential Information that has been entered into a computer, database or other electronic information storage medium by or on behalf of the Recipient or its Representatives (whether or not it was created by the Recipient or its Representatives); and
- (c) confirm in writing to the Discloser that the Recipient has complied with this clause 4.1.

This clause 4.1 does not apply to the extent that the Recipient or any Representative of the Recipient holding Confidential Information is required by law or the rules of any Regulatory Authority or any mandatory rule of professional standards applying to the Recipient or the relevant Representative to retain a copy of such Confidential Information.

## **4.2 Effect of return or destruction**

The return, destruction or deletion of any Confidential Information in accordance with clause 4.1 does not release the Recipient from its obligations under this deed.

---

## **5. Recipient's dealings with third parties**

The Recipient must not, and must ensure that its Representatives do not, directly or indirectly without the prior consent of the Discloser contact any person who is, or was in the 12 months before the date of this deed, a director, other officer, employee, adviser, consultant, shareholder, joint venture partner, creditor, customer, supplier, financier, landlord or tenant of the Discloser or a Related Body Corporate of the Discloser, to discuss the Confidential Information, the Discloser or a Related Body Corporate of the Discloser or their respective operations, affairs, business or strategic plans or a Possible Transaction.

---

## **6. No warranties, reliance or claims**

### **6.1 No warranties or reliance**

To the maximum extent permitted by law, the Recipient acknowledges and agrees that:

- (a) the Discloser and its Representatives make no representation or warranty as to the accuracy or completeness of the Confidential Information or that the Confidential Information includes all information that may be material to the Recipient in connection with the Purpose; and
- (b) the Recipient and its Representatives may not rely on the Confidential Information in any way,

except to the extent that the parties agree otherwise in any executed document relating to, or connected with, the Purpose.

### **6.2 No action against Discloser or its Representatives**

The Recipient waives and must procure that each of its Representatives waives all rights and claims that they may otherwise have against the Discloser or its Representatives in relation to the Confidential Information or any matter arising directly or indirectly in connection with this deed.

---

## **7. Breach and remedies for breach**

### **7.1 Indemnity**

Without limiting any other remedy available to the Discloser, the Recipient must pay to the Discloser on demand the amount of any loss, cost, damage, expense or other liability suffered or incurred by the Discloser or any of its Related Bodies Corporate arising out of or in connection with any breach by the Recipient of this deed (including a breach of obligation to procure that the Recipient's Representatives do or omit to do any thing).

### **7.2 Proceedings**

The Recipient acknowledges that damages alone would not be adequate to compensate the Discloser for any breach by the Recipient of this deed (including a breach of any obligation to procure that the Recipient's Representatives do or omit to do any thing) and agrees that, without limiting the relief that the Discloser is entitled to seek, the Discloser may seek an injunction against the Recipient if the Recipient is in breach or threatens to breach, or if the Discloser reasonably believes that the Recipient will breach, this deed (including a breach of any obligation to procure that the Recipient's Representatives do or omit to do any thing).

---

## **8. Term**

The obligations of the Recipient under this deed will terminate on the date which is 2 years from the date of this deed.

---

## **9. Notices**

### **9.1 How notice to be given**

Each communication (including each notice, consent, approval, request and demand) under or in connection with this deed:

- (a) must be in writing;
- (b) must be addressed as follows (or as otherwise notified by that party to each other party from time to time):
  - (i) if to the Recipient, to the address or fax number set out in Schedule 1;
  - (ii) if to the Discloser:

- (c) must be signed by the party making it or (on that party's behalf) by the solicitor for, or any attorney, director, secretary or authorised agent of, that party; and
- (d) must be delivered by hand or posted by prepaid post to the address, or sent by fax to the number, of the addressee, in accordance with clause 9.1(b).

## **9.2 When notice taken to be received**

Each communication (including each notice, consent, approval, request and demand) under or in connection with this deed is taken to be received by the addressee:

- (a) (in the case of prepaid post sent to an address in the same country) on the third day after the date of posting;
- (b) (in the case of prepaid post sent to an address in another country) on the fifth day after the date of posting by airmail;
- (c) (in the case of fax) at the time in the place to which it is sent equivalent to the time shown on the transmission confirmation report produced by the fax machine from which it was sent; and
- (d) (in the case of delivery by hand) on delivery,

but if the communication is taken to be received on a day that is not a working day or after 5.00 pm, it is taken to be received at 9.00 am on the next working day ("working day" meaning a day that is not a Saturday, Sunday or public holiday and on which banks are open for business generally, in the place to which the communication is posted, sent or delivered).

---

## **10. General**

### **10.1 Amendments**

This deed may only be varied by a document executed by each party.

### **10.2 Assignment**

A party cannot assign or otherwise transfer any of its rights under this deed without the prior consent of the other party (which may be given or withheld in the absolute discretion of that other party).

### **10.3 Counterparts**

This deed may be executed in any number of counterparts and by the parties on separate counterparts. Each counterpart constitutes an original of this deed and all counterparts together constitute one deed.

### **10.4 Severance**

If any provision or part of a provision of this deed is held or found to be void, invalid or otherwise unenforceable (whether in respect of a particular party or generally), it will be deemed to be severed to the extent that it is void or to the extent of voidability, invalidity or unenforceability, but the remainder of that provision will remain in full force and effect.

### **10.5 Waivers**

Without limiting any other provision of this deed, the parties agree that:

- (a) failure to exercise or enforce, or a delay in exercising or enforcing, or the partial exercise or enforcement of, a right, power or remedy provided by law or under this deed by a party does not preclude, or operate as a waiver of, the exercise or enforcement, or further exercise or enforcement, of that or any other right, power or remedy provided by law or under this deed;

- (b) a waiver given by a party under this deed is only effective and binding on that party if it is given or confirmed in writing by that party; and
- (c) no waiver of a breach of a term of this deed operates as a waiver of another breach of that term or of a breach of any other term of this deed.

---

## 11. Governing law and jurisdiction

This deed is governed by the law applying in New South Wales. Each party submits to the non-exclusive jurisdiction of the courts of New South Wales, Commonwealth courts having jurisdiction in that state and the courts competent to determine appeals from those courts, with respect to any proceedings that may be brought at any time relating to this deed and waives any objection it may have now or in the future to the venue of any proceedings, and any claim it may have now or in the future that any proceedings have been brought in an inconvenient forum, if that venue is in accordance with the provisions of this clause 11.
